## 1. Šī brīža aktualitāte

Kā zināms lielajiem integrētajiem projektiem (IP) un arī ekselences tīklu projektiem (NoE) ir uzdevums sludināt specifiskus konkursus dažādu darbu veikšanai un tā ir laba iespēja ikviens aktīvai zinātnieku grupai Latvijā klūt par šo lielo projektu dalībnieci daudz mazākā konkursā. Ir vajadzīga attiecīga motivācija, mobilizācija un darbs ar projektu kontraktu informāciju CORDIS datu bāzēs.

Nosacījumus atstāju netulkotus:

**Restrictions to participation:** Only TTC partners are eligible together with the coordinator of a project for which contract has already been signed or is under negotiation. Proposals for partnership extension should be submitted by the co-ordinator, acting on behalf of the Consortium of a project for which contract has already been signed or is under negotiation, together with the new participant(s) from the TTC. For contracts already signed, the remaining duration of the existing contract at the day of closure of the call must be at least 18 months. For contracts under negotiation, decision to grant EC funding shall depend on the successful conclusion of the contract under negotiation. Only TTC partners will be eligible for funding together with the coordinator who could be funded for management cost. Funding of management cost of TTC partners together with management cost for the coordinator are limited to 7 % of the Community contribution.
